

# EXTENDED COMMERCIAL LICENSE AGREEMENT

For: 2026 Roth IRA Conversion Optimizer

## 1. License Grant

You are granted a **non-exclusive, non-transferable, revocable Extended Commercial License** to use this spreadsheet within a **single firm or practice of up to ten (10) individual advisors**. This license allows each licensed advisor to view, modify, and use the spreadsheet in the course of providing financial planning services to their own clients.

This license does **not** permit use by more than ten advisors. Firms with more than ten advisors require an **Enterprise License**.

## 2. Permitted Uses

Under this Extended Commercial License, you may:

## 3. Prohibited Uses

You may **not**:

- Share, distribute, or publish the spreadsheet file or any modified version
- Upload it to **shared drives, shared cloud folders, or any company-managed storage system** accessible to more than the licensed advisors
- Provide access to unlicensed advisors, staff, contractors, or members of any organization
- Distribute exported outputs (PDFs, Excel files, or similar) to webinar or workshop attendees
- Include the spreadsheet in paid courses, coaching programs, or educational curricula
- Sell, sublicense, or include it in any commercial product or software

- Claim authorship or remove copyright notices
- Use the spreadsheet across a firm with more than ten advisors without an Enterprise License
